DESCRIPTION

ITAK-1010 was prepared from a sample of Bauxite donated by a Bauxite Mining Company from the Southeast of Brazil in 2013.

This Certified Reference Material (CRM) is presented as a fine powder.

INTENDED USE AND INSTRUCTIONS

ITAK-1010 provides an important control in analytical data from exploration and can be used as a tool for grade control in routine mining and laboratory operations.

This Certified Reference Material can be used for calibration of analytical equipment, assess and develop new methods, validation of analytical methods, and arbitration – proficiency testing for example.

The bottles/sachets content should be thoroughly mixed before taking samples of ITAK-1010.

The Certified Reference Material should be used without pre-treatment. ITAK is not responsible for any changes occurring after opening said bottles/sachets.

The Certified Reference Material should be stored in a dry place and without contact with excessive heat or moisture.

<u>CERTIFICATION AND STATISTICAL EVALUATION OF ANALYTICAL DATA</u>

ITAK-1010 was analyzed by seven specialized laboratories. The statistical evaluation was carried out according to ISO GUIDE 35 and ISO 5725-2, using: identification and treatment of outliers, stragglers and technically invalid data, certified value calculation, standard deviation calculation, and extended standard uncertainty calculation.

The Technical Report: RT-082/18 STD contains full details of all phases of manufacturing, certifying results, participating laboratories, and the statistical evaluation.

ANALYTICAL METHODS

The methods used on the certification of CRM ITAK-1010 are mentioned as follows:

- a: Fusion method and determination by X-Ray Fluorescence.
- **b**: Alkaline Digestion and determination by ICP (Bayer Process).
- c: Alkaline Digestion and determination by Gravimetric Method (Alcan Method 1086-71).
- d: Gravimetric Method.
- e: Alkaline Digestion and determination by Spectrophotometry.
- f: Alkaline Digestion and determination by Titrimetric Method.
- g: Thermogravimetric method (TGA).
- **h**: Acid Digestion method and determination by Titrimetric method.
- i: Acid Digestion method and determination by ICP-OES.
- **j**: Alkaline Digestion and determination by ICP.
- **k**: Alkaline Digestion and determination by Atomic Absorption Spectrometry.
